The bids will be opened in the presence of Bidders' representatives who choose to attend at **27-09-2075 at 2 o'clock** the office of Agnisair Krishnasabran Rural Municipality, Saptari, Province no. 2. Bids must be valid for a period of **75 days** after bid opening and must be accompanied by a bid security, amounting to a minimum giving in the formate down, which shall be valid for **30 days** beyond the validity period of the bid.
